KRA Meeting Minutes; Mar 14, 2013

President **Mark Gietzen** called the meeting to order at 7:00 pm. The meeting opened with prayer, led by **Derek Langseth**, and the flag salute led by **Larry Halloran**, the oldest veteran present. After short introductions by everyone present, **Charlotte Foster** made a motion to approve the minutes from last month's meeting. **Cindy Coss** seconded the motion, which passed.

Brian Coss moved to accept the treasurer's report, as published. **Debbie Baker** seconded it, and it also passed unanimously.

Four candidates, who are engaged in General Election races for the Wichita City Council, were present. Each candidate introduced himself with a short opening introduction, and then answered a wide variety of questions from the floor. The candidates present were:

1. **Dave Thomas**, running in District-1
2. **Clinton Coen**, who is running for the District-3 position against incumbent James Clendenin (*invited but not present*).
3. **Jeff Blubaugh** who is running against Joshua Blick in District-4. And,
4. For District-6, it was **Marty Mork**, who is competing against the severely corrupt incumbent, Democrat Janet Miller.

Questions included topics such as closing Southeast high School, lowering the city's debt, why Wichita

has both a Mayor and a city manager, neighborhood swimming pools, TIF's and CID's, a passenger rail service from Wichita to Oklahoma City and more.

The candidates agreed on nearly all of the points each one brought up as they answered questions, and it was obvious to all, that should these four candidates win their elections; the Wichita City Council would be dramatically different. Following the forum, **Craig Gabel** made a motion to endorse all four candidates. **Debbie Baker** seconded the motion. This passed unanimously.

Larry Halloran, 912 Group, gave a report on the state legislature and how bills are moving along, or not moving along, in the various committees. Some of the bills he discussed were the Fair Tax, Gun Rights, Education and more. Larry also handed out a very well written letter regarding Common Core, and he encouraged everyone to contact legislators on any or all of the issues that he spoke about.

At 8:30 p.m., after the closing announcements were made, President **Mark Gietzen** recommended that every person present offer at least some financial help or some time to one or more of the newly endorsed candidates after the meeting. **Diana Long** moved that the meeting be adjourned. **Larry Halloran** seconded the motion, and the meeting was adjourned, however, Gietzen's last minute recommendation was well received, and the majority of those present came forward to offer help to the four candidates present.
