KRA Meeting Minutes

April 11, 2013

President **Mark Gietzen** called the meeting to order at about 7:04 pm. **James Kilpatrick** led us in prayer, and the oldest veteran present, **Joseph Elmore**, led the flag salute.

After short introductions by everyone present, **James Kilpatrick** made a motion to approve the minutes from last month's meeting and **Joseph Elmore** seconded the motion. Motion passed.

Charlotte Foster moved to accept the treasurer's report, as published. **Al Aliston** seconded it, and it also passed unanimously.

Newly elected school board member, **Joy Eakins**, spoke about why she ran for USD-259 school board and what she hopes to accomplish. Questions from the members included topics on Common Core and curriculum standards, using taxpayer money to sue for more tax money, budget differences between private schools and public schools, salaries and pay raises of school

administrators, school safety and more. Discussion was very lively, as it usually is at KRA meetings, and the KRA members were happy to learn where Joy stands on these issues.

During the announcements, there was discussion among the members about several items. One of those ended with a vote on whether or not to place the KRA monthly Treasurer's reports on the website. **James Kilpatrick** made a motion to place the reports on the website. **Joseph Elmore** seconded the motion. Motion passed with one dissenting vote.

Chris Brown, who has spent a lot of time in Topeka the past few months, gave a brief legislative update. Although some in Kansas have been disappointed with slow movement on some issues, so far 2013 has been a year of significant progress on many issues that are important to conservatives. It is expected that there will be more victories before the legislative session ends.
