March 13, 2014

The two announced 4th District candidates for the Sedgwick County Commission, incumbent **Commissioner Richard Ranzau** and challenger, **Melody McCray-Miller**, spoke at the KRA Candidates' Forum this evening. While still six months ahead of the primary election, this race has generated interest because of the stark differences in both policy and style between the two candidates. These differences were evident, and at times extreme, during tonight's forum.

President **Mark Gietzen** called the meeting to order at 7 p.m. **James Kilpatrick** offered the opening prayer, and after the flag salute, we moved right to last month's minutes. **Chris Brown** made a motion to approve the minutes and **Greg Rose** seconded the motion. **Bill Spaulding** moved to approve the treasurer's report; **James Kilpatrick** seconded. Both motions passed unanimously.

Following a short introduction by Secretary **Debbie Baker**, **Melody McCray-Miller** began her opening remarks noting her background experiences and the reasons she seeks the County Commission seat. Community and safety are her top priorities, and she mentioned several government and community agencies

that if called upon, could make communities better. She also mentioned being open-minded, with a desire to listen to the people in order to implement what she called a "common agenda."

Commissioner Richard Ranzau, after a short introduction by Secretary **Debbie Baker**, opened his comments by saying, "We are a Constitutional Republic. The power is in the sovereign individual." He also noted that as citizens, we can and should make our own futures rather than being dependent on the government to sustain us. He also noted that government should be kept in its proper place and be fiscally responsible.

Following the candidates' short introductions, the floor was opened for questions. The members asked tough and pointed questions, which made for a lively discussion. With every answer, the differences between the candidates became progressively clearer.

After the forum, President **Mark Gietzen** moved on to other items on the agenda, one of which was a discussion of the Wichita City Council's proposal to change the name of the Wichita Mid-Continent Airport to "Ike Eisenhower Airport." A vote was taken. Only four people agreed that the name of the airport should change; two of the four wanted a different name entirely. 11 people did not want the airport name to change at all. Others had no opinion one way or the other, but many of the members present were against spending ANY tax dollars for something so trivial, so unpopular and so unnecessary.

After **Craig Gabel** and **Chris Brown** gave a brief legislative update on the bills in Topeka that are being followed by the KRA and K4L, **James Hodges** made a motion to adjourn. The motion was seconded and the meeting adjourned at approximately 8:51 pm.
