KRA Meeting Minutes

June 12, 2014

Mark Gietzen called the meeting to order at 7 p.m. **James Kilpatrick** gave the opening prayer and **Jim Hudson**, the oldest veteran present, led the Flag Salute.

The minutes and treasurer's report were discussed, motions made and seconded, and then approved by a voice vote. Of special note regarding the treasurer's report is that only the four top lines, and the four bottom lines, with each associated dollar amounts were approved. **Mark** was unable to update the specifics of income and expenditures shown in the middle of the Treasurer's Report due to computer technical problems. **Mark** stated that the only significant dollar expenditure was wages paid to Lauren Holroyd, a lobbyist who is working on the Fluoride Bill, HB-2372. Specifics of all income and expenditures will be detailed on the next Treasurer's Report, [below] and the current Treasurer's Report will be updated prior to being posted in the KRA website.

Special guests tonight were four Primary Election candidates for Judge. **Linda Kirby** and **Seth Rundle** are running for 18th Judicial District Judge in Division-05; **Michael Hoelscher** and **Diane Sherwood-Cocking**, each hope to be the Republican candidate for Judge in Division-19.

Introductory statements were given by each candidate, followed by questions from the audience. **Ken Ciboski**, WSU Professor, asked the first question; he wanted to know if the candidates believe judges should be elected, or whether they should be appointed. Diane was the only candidate who prefers appointment over election by the people.

Another question from the audience was how many women currently serve on the bench in Sedgwick County. Of course, the two women, **Linda** and **Diane**, stated their belief that there are not enough women judges and that perhaps they are better qualified than their men counterparts BECAUSE they are women. This 'reasoning' did not resonate well with female KRA members, as the endorsement votes showed.

Mike, who stated more than once that he believes in upholding the

Constitution, made two outstanding points; 1) People need to elect the most qualified candidate for judge regardless of race, gender, etc., and 2) Judges should not advocate from the bench, but should follow the law as written.

Closing statements: **Diane** reiterated once again that Sedgwick County needs more women judges. **Seth** and **Mike** re-stated their conservative, pro-life and pro-family convictions, and **Mike** pointed out the curious fact that **Diane** switched her registration to Republican just 45 days prior to filing as a candidate for Judge. In **Linda's** closing statements, she reminded us that she's a Conservative Republican 'woman.'

Immediately following the forum, KRA members voted by private ballot, their choice for Judge in both District 5 and 19. Votes were counted immediately. Results are as follows:

Div-05	Seth Rundle – 8 votes	Linda Kirby – 4 votes
Div-19	Mike Hoelscher – 8 votes	Diane Sherwood – 4 votes

Eric Henderson offered a motion to table the Insurance Commissioner Endorsement vote to allow all KRA members to vote electronically. **Mark Gietzen** explained that KRA members in distant parts of the state want to have input on the important Insurance Commissioner Endorsement vote. This new phenomenon of distant KRA members wanting to be part of the official KRA is caused by the closing of the "renegade KRA" which split from the National Federation of Republican Assemblies in 2004, and operated illegally using the KRA name until a few months ago when they ceased operations and removed their web-site. The main reason the renegade KRA closed is due to candidates across Kansas refusing to accept the renegade KRA endorsements, due to our warning to the candidates. **Mark** said that it is now time to bring all of the 'homeless' KRA members into the Official KRA Organization.

After announcements and old/new business, **Eric Henderson** moved to adjourn the meeting. **Al Alliston** seconded the motion. Meeting adjourned at about 8:45 pm.
